1. Call to Order

Vanessa Goldberg-Drossman opened the meeting at 6:32 pm.

2. Adoption of September 2022 Agenda

Vanessa Goldberg-Drossman asked for a motion to adopt the September 2022 agenda. Sara Bloom made the motion to adopt, Tanya Jones seconded, and the motion carried unanimously.

3. Approval of the August 2022 Minutes

Vanessa Goldberg-Drossman asked for a motion to approve, and Sara Bloom made a motion to approve the August 2022 minutes. Rev. Linda Tarry-Chard seconded, and the motion was carried unanimously.

4. School Leader Report

Emily Carson, Harlem Hebrew's Head of School updated the board on the following:

Busing

- HHLA works with 3 busing companies
 - Busing for Students with Specific Requirements for It in Their IEPs
 - Busing for Manhattan Students through OPT (NYC Office of Pupil) Transportation) provided by DOE
 - Private busing Harlem Hebrew pays to support our students living in the Bronx
 - Operated by a private company, Selby Transportation.
 - If your student's bus is delayed, please contact them directly at 718-881-1010

Reminders

- All requests for adding your student to the bus roster or changing their stop generally take 48-72 business hours
- Requests for Changes should be directed to the Harlem Hebrew Operations Team in the Main Office at opsteam@harlemhebrewcharter.org OR calling 212.866.4608
- Students in the 7th and 8th grades that live in Manhattan do not qualify for busing unless they have an IEP that requires busing
 - This is an NYC Policy and not something Harlem Hebrew has the capacity to change
 - HHLA can offer MetroCards to these students if they visit the main office
- Student Behavior on the Bus
 - HHLA has a very strict Bus Code of Conduct

Bus Attendants

- Paid from HHLA budget
- Actively interviewing potential Bus Attendants since as early as last May
- This past Monday, two Bus Attendants started at Harlem Hebrew
 - Assigned to the largest Bronx Buses
 - Ms. Schnaduer on Bronx Bus #2 and Ms. Beverly on Bronx Bus #3.



- HHLA hopes to have Bus Attendants on all Bronx Buses as soon as possible

 - Currently there is a waitlist for Pre-K
 - Total enrollment number is 475

5. Network Leadership Report

Lauren Murphy shared the following on behalf of Hebrew Public:



- School Openings
 - The Hebrew Public team supported all 5 schools opening within the last 2-3 weeks, specifically, welcoming our newest Staten Island Hebrew Public Families
- COVID-19 Updates
 - Hebrew Public made some changes to the COVID policies from last year based on guidelines from the CDC
 - New policies are subject to change as COVID continues to evolve, and as new evidence emerges about the most effective methods of controlling COVID's spread
 - Optional Masking
 - Staff and students will continue to have the option to wear (or not wear) a mask, except in cases where someone has COVID or has been exposed to someone with COVID
 - Quarantine no longer required in cases of exposure without infection
 - On-Demand rapid testing
 - Schools have rapid test kits available for symptomatic staff and students. Testing will be required on Days 5 and 6 for anyone who has been exposed
 - Reduced quarantine period
 - The quarantine period for someone with a positive COVID-19 test result has been shortened to five days from ten days
 - Learning during quarantine
 - Important to support families and students during quarantine to avoid further learning loss if a student has tested positive for COVID but is asymptomatic so in this situation, Hebrew Public will provide at-home work assignments and school staff will complete a minimum of two progress check-ins during an asymptomatic student's quarantine period
 - These changes are all in support of keeping students healthy while keeping all students in school

6. Public Comments

No public comments were made during this time.

7. Executive Session

Sara Bloom recused herself from participating in executive session.

Vanessa Goldberg-Drossman made a motion to enter executive session, Tanya Jones seconded it, and the motion was carried unanimously.

The board completed the CMO evaluation, no votes or motions were made during this time.



Vanessa Goldberg-Drossman motioned to exit the executive session, Rev. Linda Tarry-Chard seconded the motion, and the motion was carried unanimously.
