CHANGE OF TOTAL NUMBER OF DAYS FOR THE SCHOOL YEAR

NOVEMBER 27, 2018

The resolutions hereinafter set forth as the action of the Board of Trustees of HEBREW LANGUAGE ACADEMY CHARTER SCHOOL 2 (the "School") have been duly adopted at a meeting of the Board of Trustees of the School (the "Board") duly called and held for such purpose, and do hereby direct that these Resolutions be filed in the minute book of the School:

WHEREAS, Hebrew Language Academy Charter School 2 (the "School") was granted a charter by the Department of Education of the University of the State of New York (the "Authorizer") on or about November 15, 2016, to operate pursuant to its charter application

(the "Application") which was incorporated by reference into the Charter Agreement (the "Agreement") signed by and between the Authorizer and the School on or about October 25, 2016;

WHEREAS, the Board has since determined that the School should align its academic calendar with many of the schools with said Authorizer;

WHEREAS, after due consideration and planning the Board has determined that 180 days of sessions will be more than sufficient for instruction and, will increase the productivity of both the school staff and student body;

THEREFORE, the Board shall change the number of school days to 180 effective the school year 2019-2020 pending approval from the Authorizer;

Be it RESOLVED, that the new aforementioned total of school days per calendar year will be amended to this order in the School's Charter
