  - Projected enrollment
    - 57 K
    - 57 Ist grade
    - 57 2nd grade
    - 171 Total expected
  - Many families are still in the process of completing enrollment and registration requirements
- Hiring updates
  - One general education teacher is needed
    - I extra classroom teacher
  - One Interventionist
    - Pulls students out for extra support or pushes into classrooms
- Leadership Institute
  - Network-wide professional development took place at HLA in Brooklyn this week for all leaders
- Planning Update
  - Building set up
    - Deep cleaning
  - Curriculum Update
    - A network-wide shift for ELA
      - Used very successfully across the schools
      - Working with teachers to get all training needed
    - Eureka math (has not changed)
    - Number stories (has not changed)
    - Science curriculum this year!
  - School Systems
    - Arrival and dismissal
      - Operations and leadership staff is working on the logistics
      - Adding a new grade this year, there will be adjustments
      - Once finalized, all systems and procedures will be shared with families ahead of the first day
  - Staff Onboarding
    - August 17 for new teachers
    - Supported by network
    - Academic expectations are high and strong culture
    - September 5
      - Students return
      - Leaning into lifelong learning OLAM value
  - Community & Parent Partnerships
    - Coffee with Lissette
    - Gardening event in late August
    - Opportunities for feedback from families
