I. Call to Order

Adam Miller asked for a motion to start the meeting at 6:04 pm. Mike Tobman made the motion and called the meeting to order.

2. Adoption of the August 2023 Meeting Agenda

Adam Miller asked for a motion to adopt the August 2023 meeting agenda. Alice Li made a motion to adopt the meeting agenda, Mike Tobman seconded, and the motion was carried unanimously.

3. Approval of the July 2023 Minutes

4. Adoption of HLA2's 23-24 School Safety Plan

As per Section 155.17 of the Commissioner of Education's Regulations, charter schools do have to draft, publicly notice, and adopt a safety plan with a 30-day public comment period. That period began on July I, when the safety plan was posted on the school's website. All members of the public were invited to attend the July board meeting if they wanted to make a public comment regarding the plan. Adam Miller asked for a motion to adopt HLA2's 23/24 school safety plan, Sue Fox made the motion, Mike Tobman seconded, and the motion was approved unanimously with no abstentions or objections.

• Enrollment Update

- HLA2 has enrolled a total of 110 new students for SY 23-24
- Waitlists in grades 3-5
 - Kindergarten is fully enrolled!
- We anticipate that our enrollment for SY 23-24 will look quite similar or possibly a bit larger than SY 22-23
- Staff have begun holding virtual summer visits with newly enrolled families to:
 - Build relationships with families
 - Gather information about new students
 - Prepare them for a successful school year
- As of today staff have successfully held virtual visits with 43 of our new students!
