1. Call to Order

4. Adoption of SIHP's School Safety Plan 23-24



The Board all received a copy of the school safety plan for the 2023/24 year prior to the June meeting, where it was discussed and presented publicly. As per Section 155.17 of the Commissioner of Education's Regulations, charter schools do have to draft, publicly notice, and adopt a safety plan with a 30-day public comment period. That period began on July 1, when the safety plan was posted on the school's website. All members of the public were invited to attend the July board meeting if they wanted to make a public comment regarding the plan. David H. Sorkin asked for a motion to approve, Ernest Paige made a motion to approve, Sigalit Grego seconded, and the motion went to a vote, with no abstentions and no objections the motion was approved unanimously.
