Michael Coppotelli shared the following:

Team Building:

• Priority placed on team building through activities like lunch and distributing swag

Parent Communication & Engagement:

- Regular communication with parents emphasized
- Successful Parent Back-to-School Brunch, with over well 100 attendees during a workday
- Focus on continuing to increase engagement with parents

Staffing Needs:

· SIHP is in need of an MLL teacher

Cultural Representation:

 Discussion on representing all student cultures through artwork, language, and readings

Student Mental Health:

- · Licensed Master of Social Work on staff and has been since the school's founding
- 2 PhDs on staff
- · Available for assisting with all students who need the support

Community & Values:

- Importance of building a sense of values and community through marketing and enrollment
- · Majority of students are bilingual

After-School Program:

- In-house enrichment, recreation, and homework help provided Monday through Thursday
- Partnership with JCC for Friday program, including free busing from SIHP to JCC

B. Head of School Update

Amanda Ainley provided an update on the following:

Student Performance:

- MAP Growth tests are a nationally normed, standardized test that measures what students know and informs what they're ready to learn next by using a computeradaptive test that adjusts to the ability and knowledge of the student
- MAP Testing was conducted at SIHP last week
- This information was shared with families via Parent Square in multiple languages
- Students will take the test again in January as a mid-point check-in
- More information will be shared in October

The Board had a discussion and asked questions.
