David Sorkin called a meeting of the board of trustees of Staten Island Hebrew Public to order on Wednesday Feb 12, 2025 at 7:14 PM.

### **II. Board Actions**

### A. Adoption of the Meeting Agenda

Anna Maftser made a motion to adopt the February 2025 meeting agenda.

Noemi Zibuts seconded the motion.

# C. Resolution to Change the Total Number of Days for the School Year Pending NYSED Approval

Rachel Amar made a motion to adopt a resolution to change the total number of days in the school year to 180 days pending NYSED approval.

Anna Maftser seconded the motion.

Michael Coppotelli provided an explanation for decreasing the number of school days and aligning the school calendar with the DOE calendar. The total number of school days will be 180 days if approved by NYSED.

The board **VOTED** unanimously to approve the motion.

### D. Approval of the 2025-26 Academic Calendar

### III. School Report

### A. Head of School Report

Amanda Ainley led an Education Committee meeting prior to the board meeting where she reviewed all of the school's testing data with the board.

Michael Coppotelli addressed the academic achievement and shared more about collaboration with Hebrew Public Network team and curriculum vision.

Some recent school highlights include:

- Staten Island Borough President visited to tour the school
- School Culture
  - In celebration of Respect for All Week, from Monday, February 10th to Friday, February 14th, the school community will participate in various activities and theme days to promote kindness, diversity, and inclusivity among students and staff. Each day will have a special theme to encourage participation and unity.
    - Monday, 2/10 Pajama Day: "We are putting bullying to bed!"
       Students are encouraged to wear their pajamas to school
    - Tuesday, 2/11 Kindness Day & 100 Days of School: Students will
      participate in a schoolwide activity, filling each other's hearts with
      kindness. Students can dress up as all things related to the 100th day
      of school
    - Wednesday, 2/12 Diversity Day: Students are encouraged to wear clothing that represents their culture
    - Thursday, 2/13 Twin Day: Each student will be randomly assigned a twin in their class. Teachers will inform students who their twin is and what color to wear Students can coordinate outfits to be as creative as possible!
    - Friday, 2/14 Spread Love Day: Students are encouraged to wear red, white, or pink to celebrate either the 100th day of school or Valentine's Day
  - All of these initiatives help with student attendance and spreading joy in the building.
- Student Enrollment
  - Currently at 191 students
  - Setting goals for conversion rates in terms of applications to enrollment
    - Typically, 50% of the applicants apply and attend; so the goal is for around the 75% to 80% conversion rate
    - Currently, 82 new applications for next year
  - · Continuing with aggressive student recruitment marketing

### **IV. Executive Director Report**

### A. School Facilities

Michael Coppotelli provided a brief update to the board regarding building facilities. This was discussed extensively last month. SIHP is looking to expand its space into the

building next door. Michael continues to meet with the landlords often and has an upcoming meeting with DBI- construction consultants.

### B. School Staffing Update for SY25-26

SIHP has hired an additional MLL interventionist. The goal for the future is to have an interventionist at every grade level. Leadership has met with the Network Team to discuss priorities for staffing needs next school year.

### C. Finance Update

Michael shared that next year's school budget planning is in progress and he has been working closely with the CFO at Hebrew Public to ensure all staffing positions are accounted for. Hebrew Public has been largely subsidizing the school but that will no longer be the case for next year. The school will also be responsible for paying the management fee.

### V. Network Report

### A. Hebrew Public Leadership Report

Emily Fernandez, Chief Schools Officer provided a brief report on Network parallels:

- HLA just completed their renewal process and will hear about their result in the spring
- HLA2 is also in the charter renewal process and currently waiting for the NY Board of Regent's vote including middle school expansion
- · Philly received their 5-year charter renewal last spring
- · Supporting a charter in Stamford CT which was approved a month ago
  - Funding for the school will be a separate legislative session
