I. Call to Order

Ellen Green called the meeting to order at 6:03 p.m.

2. Adoption of July & August 2025 Agendas

5. School Leadership Report

HLA's Head of School, Daniella Steinberg, presented the monthly dashboard, noting enrollment at 85% of authorized levels, with growth in kindergarten applications. She also shared facility updates, including plans for a new technology lab for grades 5–8.

Ms. Steinberg shared information about upcoming events, including mandatory family orientations on Aug. 26–27, a Welcome Back Carnival on Aug. 31, and the first day of school on Aug. 28.

6. Network Report

Valerie Khaytina provided an update from Hebrew Public and commended Daniella and her team for their exceptional work. The kindergarten class for this year will be the most diverse in years, with strong programming to boost future recruitment. An old recruitment video



repurposed as a social media reel has garnered thousands of views, generating new applications. New initiatives for this year at HLA, include a Brighton Ballet residency (Latin ballroom for grades 3–4), Lego robotics for K–2, and expanded extracurriculars such as soccer, Specialized High Schools Admissions Test (SHSAT prep), and volleyball.
